Note about land held by Conservation Authorities:

- MNR cannot dictate to CAs how they use CA owned land. CAs have a regulation that allows them to issue permits, charge fees and otherwise control the use of their land. The specific policies are approved at by respective CA Boards.
- Permits for hunting activities can be issued by a CA (e.g.by Niagara Peninsula Conservation Authority to grant access to the public to hunt on their land in certain locations). This is similar to the practice of private landowners granting permission to hunters to access their property.
